

**Office Order**

Mr. Md. Shamsul Bari, Chairman, 08 No. Chargopalpur Union Parishad, Mehendiganj, Barishal has been granted Ex-Bangladesh leave to perform Holy Umrah in Saudi Arabia for 15 (fifteen) days from 31.08.2023 to 14.09.2023 or the date of departure under the following terms and conditions.

- As per provision of Rule 34 of Appendix VIII of BSR (part-1), this sanctioned leave must be availed within 35 (thirty-five) days.
- He will not be allowed to stay abroad beyond the approved period.
- He will draw his pay and allowance in local currency from Bangladesh.
- All expenses in connection with his visit will be borne by the person himself & there will be no financial involvement of the government of Bangladesh.
- The appropriate authority (respective Deputy Commissioner) must be informed prior to the commencement of the leave and a joining letter must be submitted to the authority upon arrival from the leave.
- Panel Chairman-01 will act as the Chairman of the concerned Union Parishad in his absence.


