

Office Order

Mr. Nadira Rahman, Chairman, 09 No. Tungibaria Union Parishad, Barishal Sadar, Barishal has been granted Ex-Bangladesh leave to meet her family members in Australia for 30 (Thirty) days from 15.09.2023 to 14.10.2023 or the date of departure under the following terms and conditions.

- As per provision of Rule 34 of Appendix VIII of BSR (part-1), this sanctioned leave must be availed within 35 (thirty-five) days.
- She will not be allowed to stay abroad beyond the approved period.
- She will draw his pay and allowance in local currency from Bangladesh.
- All expenses in connection with her visit will be borne by the person herself & there will be no financial involvement of the government of Bangladesh.
- The appropriate authority (Respective Deputy Commissioner) must be informed prior to the commencement of the leave and a joining letter must be submitted to the authority upon arrival from the leave.
- Panel Chairman-01 will act as the Chairman of the concerned Union Parishad in his absence.


