

Office Order

Mr. Md. - As per provision of Rule 34 of Appendix VIII of BSR (part-1), this sanctioned leave must be availed within 35 (thirty-five) days.
- He will not be allowed to stay abroad beyond the approved period.
- He will draw his pay and allowance in local currency from Bangladesh.
- All expenses in connection with his visit will be borne by the person himself & there will be no financial involvement of the government of Bangladesh.
- The appropriate authority (Respective Deputy Commissioner) must be informed prior to the commencement of the leave and a joining letter must be submitted to the authority upon arrival from the leave.
