

### Office Order

Mr. Md. Humaun Kabir, Chairman, 11 No. Auliapur Union Parishad, Patuakhali Sadar, Patuakhali has been granted Ex-Bangladesh leave for the purpose of his better treatment in India for 20 (Twenty) days from the date of approval or the date of departure under the following terms and conditions:

- As per provision of Rule 34 of Appendix VIII of BSR (part-1), this sanctioned leave must be availed within 35 (thirty-five) days.
- He will not be allowed to stay abroad beyond the approved period.
- He will draw his pay and allowance in local currency from Bangladesh.
- All expenses in connection with his visit will be borne by the person himself & there will be no financial involvement of the government of Bangladesh.
- The appropriate authority (Respective Deputy Commissioner) must be informed prior to the commencement of the leave and a joining letter must be submitted to the authority upon arrival from the leave.
- Panel Chairman-01 will act as the Chairman of the concerned Union Parishad in his absence.


