

Office Order

- She will not be allowed to stay abroad beyond the approved period.
- She will draw her pay and allowance in local currency from Bangladesh.
- All expenses in connection with her visit will be borne by the person herself & there will be no financial involvement of the government of Bangladesh.
- The appropriate authority (Respective Deputy Commissioner) must be informed prior to the commencement of the leave and a joining letter must be submitted to the authority upon arrival from the leave.


