Office Order

Md. - (a) As per provision of Rule 34 of Appendix VIII of BSR (part-1), this sanctioned leave must be availed within 35 (thirty five) days;
 - (b) He will not be allowed to stay abroad beyond the approved period;
 - (c) He will draw his pay and allowances in local currency (BDT) from Bangladesh;
 - (d) All expenses in connection with his visit will be borne by the person himself & there will be no financial involvement of the government of Bangladesh;
 - (e) The appropriate authority (Respective Deputy Commissioner) must be informed prior to the commencement of the leave and a joining letter must be submitted to the authority upon arrival from the leave.


